ORDER

No. 26 - SE/S/10M-03/2022

WHEREAS the State Government, vide its order No 351-SSE/12/ES dated 6/9/2012 read with order No 840-SE(S) dated 20-9-2017, has exempted the schools under Ramkrishna Mission, Belurmth from the purview of the West Bengal School Service Commission Act, 1997 (hereinafter referred to as the said Act) in exercise of the power conferred under section 15A of the said Act subject to certain conditions mentioned therein in the order;

AND WHEREAS it has been observed by the State Government that Order No 351-SSE/12/ES dated 6/9/2012 read with order No 840-SE(S) dated 20-9-2017 does not deal with the matter of transfer of the teacher and non-teaching staff who have been recommended by the School Service Commission prior to 6/9/2012 and working in schools of Ramkrishna Mission, Belurmth;

AND WHEREAS issues regarding transfer of above referred teachers and non-teaching staff are under active consideration of the State Government;

AND WHEREAS the Ramkrishna Mission, Belurmth, vide its letter Edn-10A(1) dated 02/12/2021 has provided no objection in favour of those teachers and non-teaching staff working in their schools, who desire to avail the facilities of general transfer and transfer on special grounds.

NOW, THEREFORE, the Governor is hereby pleased to order that teachers and non-teaching staff, who are working in the schools under Ramkrishna Mission, Belurmth, on the basis of the recommendation of the School Service Commission prior to 6/9/2012 shall be eligible to avail the facilities of general transfer and transfer on special grounds as per the provisions of the West Bengal School Service Commission (General Transfer, Transfer on Special Ground and Reallocation) Rules, 2015, as subsequently amended, subject to the following conditions:

- (a) The applicant teacher or non-teaching staff working in the schools under Ramkrishna Mission, Belurmth, must otherwise be eligible for transfer as per the provisions of the West Bengal School Service Commission (General Transfer, Transfer on Special Ground and Reallocation) Rules, 2015.
- (b) No application of those teachers and non-teaching staff for mutual transfer shall be entertained.

- (c) The applicant teacher or non-teaching staff must obtain 'NOC' in expressed terms from the concerned School Authority falling under Ramkrishna Mission, Belurmath.
- (d) The vacancy caused by such transfer shall be filled up by the Ramkrishna Mission Schools as per notification no. 175-SE/JS/13 published in the *Kolkata Gazette* on 27.08.2013.
